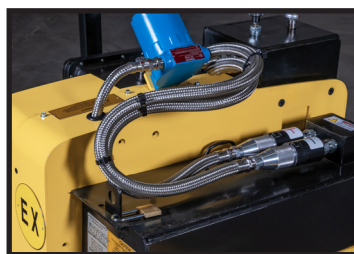

The Authority Having Jurisdiction, such as a Fire Chief or Fire Marshal, determines the hazard classification for any specific location and if an EX vehicle is required. The vehicle is built to UL 583 specifications and the enclosure has been hydrostatically tested by FRMC. Enjoy exceptional performance, unparalleled safety features as well as the quickest delivery in the industry.



**DRIVE, PUMP AND ELECTRICAL ENCLOSURES** house only electrical components and are approved to be included on EX-rated lift trucks. All RICO enclosures have been hydrostatically tested by FRMC for internal explosive resistance to pressures in excess of their requirement.



Regular cabling is sealed into a **FLEXIBLE CONDUIT (FC) CABLE**, ensuring safety, making them liquid and gas tight. The FC Cable provides flexibility and space saving.

The exposed components on the perimeter of the truck, including forks, are protected with brass and aluminum. This helps to **PREVENT ELECTRICAL FRICTION SPARKS**, which can ignite the hazardous environment. Both brass and aluminum are alloys which reduce heat and the possibility of sparking.

A **NEW BATTERY CONNECTOR** eliminates the use of a Type N connector. This connector allows for easier plug and unplug—reducing time of battery charging.

Compact design allows for **EXCEPTIONAL MANEUVERABILITY** in narrow aisles or small spaces in a hazardous environment.



We use **STATIC CONDUCTIVE LOAD WHEELS** to insure no sparks, providing a safer working environment in a truck which does not create peril or hazardous conditions. Our Static Conductive wheels are UL Certified.
